The Eco House model is a solution for vulnerable neighborhoods in Chicago suffering from urban blight, high crime, and high poverty. Eco House is a viable solution for these problems by converting vacant lots into 100 percent sustainable and off grid flower farms (we use solar powered rainwater catchment for irrigation) that teach at risk youth hands on STEM skills in construction, renewable energy, irrigation, agriculture, and workforce development through our in house flower shop called Southside Blooms.
